ADDING TO Z-WAVE NETWORK

There is one tamper key on the back side of the device, It can add, remove, reset or associate with/from the Z-Wave network. For the first time, you must join the device to Z-Wave network. First, make sure the primary controller is in the add mode. And then power on the device, after taking out the insulation Mylar in the back side of the device. The device will auto start the NWI (Network Wide Inclusion) mode, and it should be included in 5 seconds. You will see the LED lights up for one second.


